March 9	Campaigning ceases.
March 9 - April 13	CCEA Election (ALL BALLOTS MUST BE RECEIVED IN THE CCEA OFFICE BY 4:00 PM, FRIDAY APRIL 13, TO BE COUNTED ON APRIL 13. NO EXCEPTIONS!)
